Appointment of Advisor for UK and International Markets

Trigg Mining Limited (ASX: TMG) (Trigg or the Company) is pleased to advise that it has appointed an experienced corporate advisor and investor relations professional to assist with building awareness of the Company and securing new investment specifically in the UK market and internationally.

The appointment comes as the Company prepares to embark on a potentially transformational maiden air-core drilling program at its high-grade Lake Throssell Sulphate of Potash discovery near Laverton in Western Australia, where it has recently identified numerous priority palaeovalley drill targets (see ASX announcement, 7 May 2020).

The appointment of Cameron Pearce – an experienced corporate advisor and investor relations professional who has significant capital markets experience in the UK, having listed and developed several resources companies there over the past decade – will complement the Company's Australian investor relations program.

Mr Pearce's services are provided on reasonable commercial terms and include the issue of up to 4,000,000 quoted options exercisable at \$0.20 per option on or before 31 October 2021 (**Options**) during the term of the agreement.

A total of 2,000,000 Options have been issued to Mr Pearce under the Company's 15% placement capacity under Listing Rule 7.1.

An Appendix 3B has been lodged separately and an Appendix 2A follows this announcement.
