## ASX ANNOUNCEMENT

# Issue of Options to Underwriter and Lead Manager

Trigg Mining (ASX: TMG) advises that it further to the ASX announcement of 15 October 2020, and following receipt of shareholder approval at the annual general meeting held earlier today, a total of 3,066,120 options (**Options**) have been issued to Mahe Capital Pty Ltd (ACN 634 087 84) (AFSL 517 246) (**Mahe Capital**).

Mahe Capital acted as Lead Manager and Underwriter to the Rights Issue and advised Trigg on the Rights Issue and Follow-on Placement which raised \$3.1 million from existing shareholders and new institutional and professional investors.

The Options have an exercise price of \$0.25 per option and an expiry date of 31 October 2022.

An Appendix 2A follows this announcement.

### **Secondary Trading Notice Pursuant to Paragraph 708A(5)(e) of the Corporations Act 2001 ("Act")**

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, a sale of the Options noted above will fall within the exemption in section 708A(5) of the Act.
