# Infrastructure Boost for Lake Throssell

*\$678m in new Federal and State Government funding announced to upgrade The Outback Way, which will connect Trigg's Lake Throssell Sulphate of Potash Project tenements east of Laverton with key domestic and international export markets.*

### Highlights

- Trigg acknowledges the Ngaanyatjarra, the Nangaanya-Ku and the Yilka Peoples, on whose lands the Lake Throssell Sulphate of Potash (**SOP**) area is located in Western Australia
- Outback Way Funding announced by Federal and State Governments to seal the road extending from 40km east of Laverton to the WA-NT border.
- This key national transport route will improve safety and efficiency of access to Trigg's tenure, including its flagship 100%-owned Lake Throssell SOP Project.

Trigg Mining Limited (**ASX: TMG**) (**Trigg** or the **Company**) is pleased to advise that its 100%-owned Lake Throssell Sulphate of Potash (SOP) Project has received a significant infrastructure boost as a result of the announcement of Federal and State Government funding support to complete the sealing of the Outback Way linking Laverton in WA to Winton in Queensland.

Trigg Mining Managing Director and CEO Keren Paterson said: *"The Australian and WA governments recognise the strategic significance of Sulphate of Potash as a fertiliser with the potential to improve soils, water quality and carbon farming opportunities in Australia and globally and the development of this vital piece of national infrastructure will support Trigg's ambition to develop the Lake Throssell Project.*

*"With work already underway on the road as a result of previous funding to seal the first 147km by mid-2026, the additional funding provides certainty for investors and the community and means that works in WA will be completed by the end of the decade.*

*"Upgrading of the Outback Way through Trigg's tenure prior to start of construction will improve the safety and efficiency of site access during development and operations at Lake Throssell.*

*"We are pleased that the mining industry's presence in the region has added to the business case for governments to develop the road, which will also improve community safety and open up tourism opportunities. The development of the Lake Throssell Project will provide significant employment in a remote region."*
